Resolution No. 43 (2023)

WHEREAS, the Eastern Band of Cherokee Indians (EBCI) Water and Sewer Program is responsible for protecting public health by providing safe, adequate drinking water to our customers and visitors, to ensure sanitary sewer is treated to ensure proper environmental stewardship, and to perform repairs and maintenance on distribution and collection lines across the Qualla Boundary; and

WHEREAS, the EBCI faces a critical need to enhance its water and sewer operations and maintenance (O&M) infrastructure to meet the challenges of a changing environment and growing population; and

WHEREAS, the Water and Sewer Program has identified a funding source from the U.S. Environmental Protection Agency (EPA) Office of Water and Office of Wastewater to expand awareness about senior, supervisory, and leadership job opportunities in the drinking water and wastewater utility sector, address the workforce needs of water utilities through leadership development, occupational training, mentoring, or cross-training programs through the "Building Tomorrow's Water Guardians" program; and

WHEREAS, no personnel costs will be covered by this grant; and

WHEREAS, there is no grant match required.

NOW THEREFORE BE IT RESOLVED by the Tribal Council of the Eastern Band of Cherokee Indians, in Council assembled, at which a quorum is present that the EBCI Water and Sewer Program be authorized to apply and accept funding from the US EPA Office of Water and Office of Wastewater in the estimated amount of \$1,000,000 for fiscal years 2024-2028.

BE IT FINALLY RESOLVED that the Principal Chief is authorized to carry out the intent of this resolution, which shall remain in effect until implemented or rescinded.
