13 14	WHEREAS,	on January 26, 2010, Tribal Business Committee approved the transfer of Birdtown Community Parcel No 133, containing 0.7 acres, more or less, with all
1 4 15		improvements thereon, to Bessie Murphy Myers' son, Daniel Robert Estes Myers,
16		and his four children, one of which is a minor, Lauren Iana Dawn Myers (dob
17		09/19/2007), Thomas Michael Myers, Asija Daniel Robert Myers, and Meli
18		Miranda Myers; and

20	WHEREAS,	the parcel included the Mutual Help Home that was built thereon by Qualla Housing
21		Authority, and which was occupied by Ms. Myers, who retained a life estate
22		therein; and
23 24	WHEREAS,	Ms. Myers passed on March 9, 2010, terminating the life estate and leaving Daniel
24 25	WHEREAS,	Myers and his four children as the sole owners of the property; and
26		111/010 and the roat official as the sole owners of the property, and
27	WHEREAS,	the home has been destroyed by fire and the remnants have been removed from the
28		parcel; and

30	WHEREAS,	Daniel Myers wishes to build a new home on the parcel, which he will occupy with
31	•	his children, who also have an ownership interest in the parcel; and
32 33	WHEREAS,	Tribal Council angested Passalution No. 422 (2022) authorizing the execution of a
34	WHEREAS,	Tribal Council enacted Resolution No. 432 (2022) authorizing the execution of a lease, assignment, promissory note, and other documents so that Mr. Myers could
35		obtain a mortgage loan from the Tribe, and that it was in the best interest of Mr.
36		Myer's then two minor children for Mr. Myer's to obtain the mortgage loan, but
37		only on the condition that he obtained consent from his two adult children who
38		maintain an ownership interest in the parcel, Asija Daniel Robert Myers and Meli
39		Miranda Myers; and

11	WHEREAS,	since the passage of Resolution No. 432, Mr. Myers has made multiple attempts to
12		obtain consent from his adult children and they either cannot be located because
1 3		they no longer live in the area, or are unwilling to consent to the mortgage loan on
14 15		the parcel; and

1 2 3 4	WHEREAS,	the Cherokee Indians Division of Housing has approved Mr. Myers to receive a mortgage loan, encumbered by a lease and assignment, so that he may build a new home on the property and live there with his family, including his minor child; and
5 6 7	WHEREAS,	Mr. Myers cannot replace the home without the loan from the Cherokee Indian Housing Division; and
8 9 10 11 12 13 14 15	WHEREAS,	Mr. Myers requests Tribal Council to exercise its comprehensive authority over Tribal real property pursuant to § 16 of the Charter and Governing Document, to authorize the creation, execution and approval of a lease, assignment, promissory note, and any other document necessary in the normal course of business to encumber the property and by which Mr. Myers may obtain the loan to build the house for himself and his family, as previously authorized by Resolution No. 432, and without the consent of Asija Daniel Robert Myers and Meli Miranda Myers.
16	NOW THER	EFORE BE IT RESOLVED by the Eastern Band of Cherokee Indians in Council
17 18 19 20 21	NOW TILK	Assembled, at which a quorum is present, that the necessary Tribal divisions and programs, and the Tribal Business Committee, are authorized to create, execute and approve the customary form of lease, assignment, promissory note, and other documents by which Daniel Robert Estes Myers may apply for and, if qualified, obtain the mortgage loan he is seeking from the Tribe, and to execute those
22 23 24 25 26		documents so that Birdtown Community Parcel No. 133, containing 0.7 acres, more or less, with all improvements thereon, are pledged as security for the loan by Daniel Robert Estes Myers without the signatures of Asija Daniel Robert Myers and Meli Miranda Myers.
27 28 29 30 31 32	BE IT FURT	HER RESOLVED that it is in the best interest of the minor child who has an ownership interest in the property Lauren Iana Dawn Myers (dob 09/19/2007) to grant the authorizations described in this resolution, and to allow the property to be pledged as collateral for the mortgage loan. Their minority shall not preclude the execution and approval of the necessary documents by Daniel Robert Estes Myers.
33 34 35 36	BE IT FURTE	HER RESOLVED that nothing in this resolution exempts Daniel Robert Estes Myers from having to satisfy requirements imposed by the Cherokee Indian Housing Division including, but not limited to employment, income, and credit.
37 38 39 40	BE IT FURT	HER RESOLVED that the Cherokee Indian Housing Division, the Tribal Realty Services Office, and the Tribal Business Committee are authorized to carry out the intent of this resolution.
41 42 43 44	BE IT FINAL	LY RESOLVED that all resolutions that are inconsistent with this resolution are rescinded, and that this resolution shall become effective when ratified by the Principal Chief.
