36	NOW THEREFORE, BE IT RESOLVED by the Tribal Council, in Council assembled			
37	with a quorum present, and with the number of votes required by Tribal law,			
38		DUSTIN LEWIS MONTI is hereby PERMANENTLY EXCLUDED from all		
39	Tribal lands and is hereby notified and ordered to vacate all tribal lands.

1	BE IT FURTHER RESOLVED that this permanent exclusion prohibits DUSTIN LEWIS MONTI from entering or being present on Tribal lands for any purpose except as required by	
2		
3	Tribal Council or Tribal Court.	
4		
5	BE IT FURTHER RESOLVED that if DUSTIN LEWIS MONTI is found improperly on	
6	Tribal lands at any time after the effective date of this resolution, he shall be	
7	treated as a trespasser and appropriate legal action shall be taken against him.	
8		
9	BE IT FINALLY RESOLVED that all resolutions inconsistent with this resolution are rescinded,	
10	and that this resolution shall become effective when ratified by the Principal	
11	Chief.
