WHEREAS, Mary Louise Sneed Welch, Patricia Eldean Sneed Lambert, Howard Vincent Sneed, and Carla Marie Sneed Ballew are the owners of Painttown Community Parcel No. 28-A, containing 3.695 acres, more or less; Parcel No. 28-B, containing 3.686 acres, more or less; Painttown Community Parcel No. 28-C, containing 3.686 acres, more or less; Painttown Community Parcel No. 28-D, containing 3.686 acres, more or less; and Painttown Community Parcel No. 699, containing 0.519 acres, more or less, together with all improvements located thereon; and

WHEREAS, the parcels are located adjacent to each other, and the total acreage consists of 15.272 acres, more or less; and

WHEREAS, the owners have offered to sell the above-described parcels to the Tribe and the purchase price for the 15.282 acres is Two Million Three Hundred Thousand and Eighty-Two Thousand Dollars and 00/100 cents (\$2,382,000.00), the appraised value of the property; and

WHEREAS, the Tribe desires to purchase the properties subject to an agreement to purchase over multiple installments that is to be negotiated by the sellers and the Tribe; and
