16	WHEREAS,	the Eastern Band of Cherokee Indians ("Tribe") is a federally recognized Indian	
17		tribe enjoying a government-to-government relationship with the United States; and

19	WHEREAS,	to promote economic development, Tribal self-sufficiency and Tribal self-
