42	NOW THEREFORE BE IT RESOLVED by the Tribal Council of the Eastern Band of Cherokee		
43		Indians, in Council assembled, at which a quorum is present, that the Tribe hereby	
44		grants a limited waiver of sovereign immunity, limited as provided in the attached	
45		Exhibit A, for the purpose of allowing the Tribe to purchase the requisite bond	
46		from FCCI Insurance Company, which bond is required by the North Carolina	

1 Department of Transportation per the attached NCDOT Encroachment Agreement 2 bearing Encroachment Number E142-087-25-00197. 3 BE IT FURTHER RESOLVED, that the Principal Chief is authorized to execute the attached 4 documents provided by the NCDOT and FCCI Insurance Group as necessary to 5 6 effectuate the intent of this resolution and to purchase the necessary bond, and is authorized with the Budget and Finance Office and the Office of the Attorney 7 8 General to suggest to FCCI amendments to its required documents so they 9 properly identify the Tribe as a sovereign Tribal government. 10 BE IT FINALLY RESOLVED that all resolutions that are inconsistent with this resolution are 11 rescinded, and that this resolution shall become effective when ratified by the 12 13 Principal Chief. 14 15 Submitted by Michael McConnell, Attorney General. 16 17
