WHEREAS, In accordance with Cherokee Code 117-42, Confirmation Hearings, Tribal Council

held a confirmation hearing on Monday, March 25th, 2024 for Mr. Gary Ledford

and Mr. Ledford was confirmed unanimously by Tribal Council

NOW THEREFORE BE IT RESOLVED by the Tribal Council of the Eastern Band of Cherokee Indians in Council assembled at which a quorum is present that Mr. Gary Ledford shall serve with a term beginning April 4, 2024 and expiring September 30, 2027

BE IT FINALLY RESOLVED that this resolution shall become effective upon ratification of the Principal Chief
