RESOLUTION NO. 180 (2024)

WHEREAS, Cherokee Code Sec. 92-5 establishes the Tribal Employment Rights Commission and defines membership, and,

WHEREAS, pursuant to Sec. 92-5 the Principal Chief has authority to appoint two persons to the Commission each to serve four year terms concurrently with the term of the Principal Chief who appoints them, and,

WHEREAS, Mr. Billy Brown was appointed by Resolution 88 (2019) and his term has expired, and,

WHEREAS, In accordance with Cherokee Code 117-42, Confirmation Hearings, Tribal Council held a confirmation hearing on Monday, March 25th, 2024 for Mr. Gary Ledford and Mr. Ledford was confirmed unanimously by Tribal Council

NOW THEREFORE BE IT RESOLVED by the Tribal Council of the Eastern Band of Cherokee Indians in Council assembled at which a quorum is present that Mr. Gary Ledford shall serve with a term beginning April 4, 2024 and expiring September 30, 2027

BE IT FINALLY RESOLVED that this resolution shall become effective upon ratification of the Principal Chief

RESOLUTION NO. 88 (2019)

WHEREAS, Cherokee Code Sec. 92-5 establishes the Tribal Employment Rights Commission and defines its membership; and

WHEREAS, pursuant to Sec. 92-5, the Principal Chief has authority to appoint two persons to the Commission, each to serve four-year terms concurrently with the term of the Principal Chief who appoints them; and

WHEREAS, the terms of the Principal Chief's two current appointments have expired and new appointments need to be made to fill those seats; and

WHEREAS, this resolution is presented to make the Principal Chief's appointments to the Tribal Employment Rights Commission.

NOW THEREFORE BE IT RESOLVED by the Tribal Council of the Eastern Band of Cherokee Indians assembled, at which a quorum is present, that Principal Chief Richard G. Sneed makes the following appointments to the Tribal Employment Rights Commissions:

(1) Billy Brown, who is currently serving on the Tribal Employment Rights Commission, is hereby re-appointed to his seat.

(2) Steve Coleman is hereby appointed to fill the seat held by Kevin Jackson, whose term has expired.

BE IT FURTHER RESOLVED that this resolution shall be effective upon ratification by the Principal Chief, and all prior resolutions that are inconsistent with this resolution are rescinded.






