Resolution No. 224 (2020)

- 8 WHEREAS there is growing concern and displeasure with the use of Native Nations cultural appropriation by sports teams nationally, and
- 11 WHEREAS the Atlanta Braves Baseball team resides in close proximity to the Eastern Band of Cherokee Indians and has historically utilized native American imagery and practices, and
- 15 WHEREAS the Atlanta Braves Baseball team requests assistance with developing imagery and practices that depict the rich cultural history of the Cherokee people, and
- 18 WHEREAS the Office of the Principal Chief has been requested to nominate individuals to serve on the Atlanta Braves Cultural Advisory Committee, and
- 21 WHEREAS per Resolution #165 (2020) two individuals were nominated by the Office of the Principal Chief and one individual was nominated by the EBCI Tribal Council, and
- 24 WHEREAS one individual nominated by the Office of the Principal Chief to the Atlanta Braves Cultural Advisory Committee has stepped down from this position and needs replacing.

NOW THEREFORE BE IT RESOLVED by the Tribal Council of the Eastern Band of Cherokee Indians in Council assembled at which a quorum is present, that the individual named below are hereby nominated by Principal Chief Richard Sneed, and are approved by Tribal Council, to be appointed to the Atlanta Braves Cultural Advisory Committee:

BE IT FINALLY RESOLVED that all resolutions that are inconsistent with this resolution are rescinded and that this resolution shall become effective upon ratification by the Principal Chief.




