### LORETTA ANN QUEEN

I, Loretta Ann Queen, residing on trust lands of the Eastern Band of Cherokee Indians in the Wolfetown Community in Cherokee, Jackson County, North Carolina, declare this to be my Last Will and Testament. I hereby revoke all Wills, codicils and letters of testamentary import I may have made before this Last Will and Testament. I was born on the 4<sup>th</sup> day of June 1961. I am an enrolled member of the Eastern Band of Cherokee Indians and my enrollment number is R04985.

### Item 1. Sound Mind and Memory

I am of sound and disposing mind and memory. I am under no disability that prevents me from making this Will or understanding its contents and effects. I am under no constraint or undue influence and have made this Will freely and voluntarily.

#### Item 2. My Family

For the purposes of this Will, my family consists of my daughter, grandchildren and nephew. My daughter is Amber Sneed, born March 17, 1983. My grandchildren are Kaneetha Bradley, born April 6, 2003 and Cole Robert Bradley, born August 2, 2006. My nephew is Galvin Reed, born July 19, 2010. My family members listed here are all enrolled members of the Eastern Band of Cherokee Indians.

# Item 3. Disposition of My Body, Funeral Expenses and Charitable Pledges

It is my wish that upon my death, my family will hold a viewing and then cremate my body. I direct my Personal Representative, hereinafter named, to dispose of my bodily remains in accordance with my wishes as I have expressed to him or her. In a manner and extent consistent with my wishes, my Personal Representative may erect at my grave (if any) a monument as he or she deems proper and may make arrangements as he or she deems necessary and proper for the perpetual

care of the cemetery lot on which I am buried. My Personal Representative shall not be required to secure court approval of expenditures for the perpetual care of my grave site even though the expenditures may exceed the amount otherwise allowed by law. My Personal Representative may, at his or her discretion, pay or otherwise satisfy all of my unpaid charitable pledges, even though the charitable pledges are not legally enforceable, out of my estate as soon as practicable after my death.

### Item 4. Payment of Debts and Taxes

I direct my Personal Representative to pay all my just debts, including costs of administration of my estate and estate, inheritance, success, legacy, transfer or other taxes (including interest thereon) imposed by reason of my death upon property (including life insurance) passing under or outside this Will. I direct that, in so far as possible, no taxes shall be charged against or collected from the person receiving or in possession of the property taxed or receiving the benefit thereof, for I intend that all such persons, legatees, devisees, surviving tenants by the entirety, and beneficiaries receive full benefits without any diminution on account of such taxes.

#### Item 5. Tribal Land

I give all of my possessory interests in Tribal trust land, whether presently owned by me or which may come into my hands or which I have any expectancy of receiving into my estate, as follows to my daughter, Amber Sneed. If my daughter predeceases me, then I give the same to Kaneetha Bradley and it is my wish that she divide this fairly among my descendants.

As of the time this Will is executed, my tribal land holdings include, without limitation, undivided interests in the following:

- Wolfetown Community Parcel No. 1168-A, containing 1.021 acres, more or less;
- Wolfetown Community Parcel No. 1168-B, containing 2.546 acres, more or less;
- Wolfetown Community Parcel No. 1267-D, containing 4.738 acres, more or less;
- Wolfetown Community Parcel No. 748-I, containing 4.973 acres, more or less;
- Wolfetown Community Parcel No. 370-B, containing 2.006 acres, more or less; and
- Wolfetown Community Parcel No. 560, containing 1.136 acres, more or less.

A gift of land or legal interest therein includes all of the easements and rights of way associated therewith and all the improvements on the land including, but not limited to, houses, mobile homes,

garages, barns, sheds and workshops, regardless of whether the same are or are not permanently affixed to the ground, subject to claims allowed by law.

#### Item 6. Residuary

I give all the rest, remainder and residue of my estate, both real property and personal property, wheresoever located, of every kind and nature, to my daughter Amber Sneed, if she survives me. If my daughter predeceases me, then I give the same to Kaneetha Bradley and it is my wish that she divide this fairly among my descendants

### Item 7. Distributions for Minor Beneficiaries

If any item of this Will would otherwise require a distribution to a person under eighteen (18) years of age, my Personal Representative may, in his discretion, continue to hold and administer the property subject to such distribution for the benefit of the minor beneficiary until the minor beneficiary attains the age of eighteen (18) years. The distribution of property to the parent or guardian of any minor beneficiary, or, when my Personal Representative deems appropriate, to any minor beneficiary, shall fully discharge my Personal Representative hereunder. The first sentence of this paragraph notwithstanding, my Personal Representative shall distribute all property held by him under this provision within eighteen (18) years after my death.

## Item 8. Powers and Authorities of Personal Representative

- (a) In the management, care and distribution of my estate, I give to my Personal Representative (and successors thereof) all of the powers and authorities set out in North Carolina General Statutes (N.C.G.S.) § 32-27, which are incorporated here by reference as they exist on the date I have executed this Will. These powers are granted in accord with N.C.G.S. § 32-26. These powers shall be in addition to, and not in limitation of, the powers granted by N.C.G.S. § 28A-13-3.
- (b) My Personal Representative shall be authorized to take possession, custody or control of any real or personal property in my estate or of any real or personal property not specifically devised to satisfy any devise under this Will which may be satisfied in-kind, all without the necessity of prior Court approval or notification to any beneficiaries of the estate or of any trust. If my Personal Representative determines in his discretion that he or she is not required to take possession, custody or control of any such property, his or her decision shall be binding and conclusive on all persons taking hereunder.

### Item 9. Appointment of Personal Representative

I nominate, constitute and appoint my daughter, Amber Sneed, to be Personal Representative of this my Last Will and Testament. My Personal Representative shall have full power and authority to sell any property or do any act which in her opinion is for the best interest of my estate, and no bond shall be required of her.

If my Personal Representative should predecease me, or if for any reason is unwilling or unable to qualify to serve as my Personal Representative, then I nominate and appoint Rosie Hornbuckle to serve as Successor Personal Representative, with the full powers and authorities set out in this Instrument. No bond shall be required of my Personal Representative or any successor representative expressly named by me in this Instrument.

#### Item 10. Lapsed or Failed Gifts

If any gift in this Will shall lapse or fail, that gift shall become part of my residuary estate and distributed as provided for my residuary estate.

## Item 11. Presumption of Survivorship

If any beneficiary under this Will does not survive me for a period not less than 120 hours following my death, it shall be presumed for the purpose of any distribution to or for the benefit of the beneficiary that the beneficiary predeceased me.

### Item 12. Pronouns and Plurals

In drafting this Will I have made every effort to correctly use personal pronouns and plurals. Changes in the Personal Representative and my family and beneficiaries which have or have not been contemplated in drafting this Will may render the various uses of pronouns or plurals inaccurate. When necessary to effect the intent of this Will, all pronouns and any variations thereof shall be deemed to refer to the masculine, feminine, neuter, singular or plural, as the identity of the person or persons may require.

#### Item 13. Definitions

In this Will, the following definitions apply:

- (a) "Beneficiary" means a person or entity entitled to share in property distributed according to my valid and probated Will regardless of whether the property is real estate, money or personal property. The term "beneficiary" is synonymous with the term "devisee."
- (b) "Enrolled" or "enrolled member" means a person who has been granted membership in the Eastern Band of Cherokee Indians by the Tribe.
- (c) "Gift" or "give" means the transfer of the thing at issue from me as Testator to the described beneficiary through the mechanism of this Will, and includes the terms "devise", "bequeath" and "bequest."
- (d) "Personal Representative" means any personal representative or representatives of my estate acting under this Last Will and Testament, and includes the terms executors, fiduciaries, trustees and any substitute or successor therefor, so that the power and duties given to those named shall also be given to the substitute or successor, should circumstances triggering service by the substitute or successor come into being.
- (e) "Possessory interest" or "possessory holding" means the ownership or assigned interest I have in Tribal trust land, as provided to Tribal members under Tribal law. Any reference to "possessory interest" or "possessory holding" includes the improvements thereon.
  - (f) "Tribal" or "Tribe" means the Eastern Band of Cherokee Indians.
- (g) "Tribal land" or "Tribal trust land" means land that is held in trust by the United States for the Eastern Band of Cherokee Indians.
