1 CHEROKEE COUNCIL HOUSE 2 CHEROKEE, NORTH CAROLINA 3 MAR 0 7 2024 4 Date: 5 ORDINANCE NO.: 126 (2024) 6 7 8 An ordinance amending C.C. Sec. 117-31 and establishing a new Sec. C.C. Sec. 117-38 to allow Planning Board review of capital projects that require a Tribal expenditure of \$50,000 or more, 9 10 adding members to Planning Board, and adding a requirement for regular project reporting. 11 12 WHEREAS, Cherokee Code (C.C.) Sec. 117-31 governs the Planning Board, which has 13 authority to review and approve capital projects "with respect to the Cherokee 14 Indian Reservation"; and 15 16 the Tribe funds and pursues capital projects on and off Tribal trust land, in North WHEREAS. Carolina and other states, and these projects have a significant impact on the 17 18 Tribe's budget; and 19 20 WHEREAS, C.C. Sec. 117-31 should be amended to expand the authority of the Planning 21 Board to include projects off of the reservation, and to allow projects having a 22 certain value be reviewed by the Planning Board to better inform Tribal Council 23 and the Executive Committee of the project's implications; and 24 25 WHEREAS, the Cherokee Code should be amended by adding thereto a new section, identified as Sec. 117-38.1, to allow Tribal Council to refer capital project funding 26 27 resolutions of a certain value to the Planning Board for review before Tribal 28 Council votes to approve or reject the resolution, and to allow review by the 29 Office of Budget and Finance and the production of a Fiscal Note assessing the impact on the Tribe's budget and compliance with the Tribe's financial 30 31 requirements. 32 33 NOW, THEREFORE, BE IT ORDAINED the Eastern Band of Cherokee Indians Tribal Council, 34 in Council assembled, at which a quorum is present, that C.C. Sec. 117-31 shall 35 be amended to read as follows, and a new Sec. 117-38.1 shall be established, as 36 follows:

Sec. 117-31. Planning Board.

- 2 (a) The Planning Board is created with members consisting of the following persons:
- 3 (1) Six Tribal Council Members appointed by Tribal Council to serve a term of two years, which shall be concurrent with the Council mMember's term of office.
 - (2) The Principal Chief, or his or her proxy given to the Vice Chief, to and Vice Chief, to serve a term of four years, which shall be concurrent with the executive term of office.
 - (3) Secretary of Finance, and Secretary of Commerce, and Secretary of Operations
 - (4) One Two enrolled members who is also an are owners or operators of a business within the Tribe's business community and within the Tribe's jurisdiction, to serve a term of two years, which shall be concurrent with the council member's term of office, and appointed by the Principal Chief.
 - (5) An Two enrolled members who is an are elders, of a least 59½ years of age, appointed by the Chief and Tribal Council to serve a term of two years, which shall be concurrent with the Council Member's term of office.
 - (6) The Director of the Tribal Employment Rights Office (TERO)
- (b) The Board shall elect from its members a Chairman, Vice-Chairman, a Secretary and such other officers as it may desire.
- 18 (c) The appointing authority may remove any member of the Board for cause.
- 19 (d) The members of the Planning Board shall not receive compensation for their services, but 20 shall be entitled to compensation for expenses, including traveling expenses incurred in the 21 discharge of their duties.
- 22 (e) Eight members of the Planning Board shall constitute a quorum for the transaction of business, notwithstanding the existence of any vacancies.
- 24 (f) The Planning Board shall have all the power, authority, discretion and duties with respect to the Cherokee Indian Reservation as are granted to Planning Boards which are created by the State of North Carolina.
- 27 (g) The Board shall be required to meet quarterly not less than once a month, to keep minutes of all such meetings and report to the Tribal Council at the next Council meeting following each the last Board meeting of each month.

Sec. 117-38. Capital projects and fiscal notes.

(a) Any resolution submitted to Tribal Council that requests funding of a capital project in an amount of fifty-thousand dollars (\$50,000) or more shall be referred by Tribal Council to the Planning Board for preliminary review, before Tribal Council shall vote to approve or reject the funding request presented in the resolution. For good cause, Tribal Council may vote to approve or reject a funding request greater than \$50,000 without referring the matter to Planning Board. For purposes of Section 117-38, capital projects shall be defined as a project to build or improve an EBCI capital asset, such as buildings and infrastructure.

(b) Any resolution for a capital project in an amount of fifty-thousand dollars (\$50,000) or more that is referred to Planning Board shall be reviewed by the Office of Budget and Finance to produce a Ficsal Note that includes the impact on the Tribe's budget and compliance with the Tribe's financial requirements. The Fiscal Note shall accompany the resolution if it is voted on by Tribal Council.

(c) The Office of Budget and Finance in conjunction with Project Management and EBCI program leadership shall provide Planning Board and Tribal Council with a detail project report on a quarterly basis and a financial summary project report on a monthly basis.

(d) This section shall not apply to financial contributions to Tribal entities.

BE IT FINALLY ORDAINED that all ordinances which are inconsistent with this ordinance are rescinded, and that this ordinance shall become effective upon ratification by the Principal Chief.
