RESOLUTION NO. _____ (2026)

A resolution for the Estate of James Marcus George.

10 WHEREAS, James Marcus George (deceased May 10, 2013), enrolled member of the Eastern
11 Band of Cherokee Indians did not leave a Last Will and Testament; and

13 WHEREAS, Jessica Jumper qualified as the Administratrix of the estate of James Marcus
14 George in Cherokee Court Estate File No. 13-053; and

16 WHEREAS, the Tribal Realty Office has examined the records on file regarding the deceased's
17 possessory holdings in Tribal trust land, and other documents, and has written this
18 resolution to provide for the distribution of the deceased's possessory holding to
19 their eligible heirs.

21 NOW, THEREFORE, BE IT RESOLVED by the Eastern Band of Cherokee Indians in Council
22 Assembled, at which a quorum is present that the Tribal Council of the Eastern
23 Band of Cherokee Indians does hereby recognize the heirs of James Marcus
24 George: Winnie Leigh Jumper (enrolled), Jessica Lynn Jumper (enrolled), and
25 James Marcus George, Jr. (enrolled).

27 BE IT FURTHER RESOLVED that ½ Interest in **Wolftown Community Parcel No. 386-E**
28 **(Remainder of Parcel No. 386-B)**, containing 0.916 Acres, more or less, be
29 assigned to Winnie Leigh Jumper (enrolled), Jessica Lynn Jumper (enrolled), and
30 James Marcus George, Jr. (enrolled).

32 BE IT FURTHER RESOLVED that **Wolftown Community Parcel No. 386-K (Part of Parcel**
33 **No. 386-I)**, containing 4.064 Acres, more or less, be assigned to Winnie Leigh
34 Jumper (enrolled), Jessica Lynn Jumper (enrolled), and James Marcus George, Jr.
35 (enrolled).

37 BE IT FURTHER RESOLVED that **Wolftown Community Parcel No. 1161 (Part of Parcel No.**
38 **386)**, containing 0.277 Acres, more or less, together with all improvements located
39 thereon, be assigned to Winnie Leigh Jumper (enrolled), Jessica Lynn Jumper
40 (enrolled), and James Marcus George, Jr. (enrolled).

42 BE IT FURTHER RESOLVED that **Wolftown Community Parcel No. 926 (Part of Parcel No.**
43 **386)**, containing 0.871 Acres, more or less, together with all improvements located
44 thereon, be assigned to Winnie Leigh Jumper (enrolled), Jessica Lynn Jumper
45 (enrolled), and James Marcus George, Jr. (enrolled).

1 BE IT FINALLY RESOLVED that the Tribal Business Committee and Tribal Realty Services are
2 hereby authorized to carry out the intent of this resolution.
