FOR THE PURCHASE OF A PETERSEN ATLAS-AL-2 50YD 12 GRAPPLE TRUCK 13 14 the Eastern Band of Cherokee Indians (EBCI) is a federally recognized, 15 WHEREAS, sovereign tribal nation with powers of self-governance and jurisdiction 16 over lands held in trust for the benefit of the Tribe and its citizens; and 17 18 the EBCI previously received settlement funds from Duke Energy in WHEREAS, 19 response to damages resulting from the Stony Ridge Fire, with said funds 20 held in EASTERN CHEROKEE INDIANS NORTH CAROLINA - 7224 21 -S52/001 (Account No. PL7224709) for use in activities that promote 22 restoration, environmental protection, and fire prevention; and 23 24 wildfire prevention and sustainable land management remain essential WHEREAS, **25** responsibilities of Tribal governance, especially in light of ongoing 26 climate threats and increased risk to natural and cultural resources; and 27 28 WHEREAS, the Petersen Atlas-AL-2 50 YD is a specialized vehicle designed to help 29 crews perform safe and efficient tree removal, large-scale vegetation 30 management, and hazard mitigation, especially in rugged and fire-prone 31 terrain; and 32 33 WHEREAS, acquisition of this equipment will significantly strengthen the Tribe's 34 capacity to reduce wildfire risk, and improve efficiency of tree removal 35 efforts by tribal crews; and 36 37 38 the Tribal Fleet Committee has heard and approved the purchase of this WHEREAS, 39 equipment; and 40 41 the Tribal Council finds that purchasing this equipment constitutes a WHEREAS, 42 responsible and effective use of settlement funds, in accordance with the 43 original purpose of the Stony Ridge Fire settlement. 44 45

2	Council assembled at which a quorum is present, that: funds shall be withdrawn from EASTERN
3	CHEROKEE INDIANS NORTH CAROLINA - 7224 -S52/001 (Account No. PL7224709), in
4	the amount of \$348,126.31to purchase one (1) Petersen Atlas-AL-2 50 YD Grapple Truck;

6	BE IT FURTHER RESOLVED, that the appropriate Tribal departments are authorized and
7	directed to carry out procurement of this equipment in full compliance with existing Tribal fiscal
8	policies and procurement guidelines;
9	
10	BE IT FURTHER RESOLVED, that this piece of equipment shall be placed under the
11	purview of the Tribal Construction Tree Cutting Program
12	
13	BE IT FURTHER RESOLVED, that the Office of Budget and Finance is hereby directed to
14	complete and submit the required SF-1034 form to the Eastern Region Office of the Special
15	Trustee for American Indians (OST) to ensure proper documentation and processing of the
16	associated funds; and
17	
18	BE IT FINALLY RESOLVED, that this resolution shall become effective immediately upon
19	ratification by the Principal Chief.
