(2025) 8 A resolution to exclude Christopher Dale Tredwell from the lands of the 9 Eastern Band of Cherokee Indians. 10 11 WHEREAS, the Eastern Band of Cherokee Indians ("EBCI" or "Tribe") has the sovereign 12 authority to exclude persons from lands of the Eastern Band to protect the 13 integrity, law and order of the lands, and the welfare of Tribal members; and 14 15 WHEREAS, the Tribal Council has codified its authority to exclude persons from the lands of 16 the Eastern Band at Chapter 2 of the Cherokee Code; and 17 18 WHEREAS, the power to exclude is an inherent and essential part of Tribal sovereignty that is 19 indispensable to the Tribe's autonomy and self-governance; and 20 21 WHEREAS, CHRISTOPHER TREDWELL (Date of Birth: 08/17/1988) is not a member of the 22 Eastern Band of Cherokee Indians, but is said to be residing in and around the 23 Qualla Boundary; and 24 25 WHEREAS, on July 7, 2025, CIPD officers responded to 777 Casino Drive on the Qualla 26 Boundary, where CHRISTOPHER TREDWELL was seen with another known 27 drug trafficker; and 28 29 WHEREAS, during the investigation, CIPD found that CHRISTOPHER TREDWELL was in 30 possession of a trafficking amount of fentanyl (11.5 grams); and 31 32 WHEREAS, CHRISTOPHER TREDWELL was charged with Felony Possession of Controlled 33 Substance; Possession with the Intent to, Sell, or Deliver a Controlled Substance; 34 Trafficking in Fentanyl, and Transporting controlled substance into the territory 35 of the EBCI; and 36 37 WHEREAS, TREDWELL has previously been convicted of Distribution of Methamphetamine 38 as well as Trafficking in Ice/Crank/Crack. 39 40 NOW THEREFORE, BE IT RESOLVED by the Tribal Council, in Council assembled 41 with a quorum present, and with the number of votes required by Tribal law, 42 CHRISTOPHER DALE TREDWELL is hereby PERMANENTLY EXCLUDED 43 from all Tribal lands and is hereby notified and ordered to vacate all tribal lands. 44 45 46 47 BE IT FURTHER RESOLVED that this permanent exclusion prohibits

1	CHRISTOPHER DALE TREDWELL from entering or being present on Tribal
2	lands for any purpose except as required by Tribal Council or Tribal Court.
3	
4	BE IT FURTHER RESOLVED that if CHRISTOPHER DALE TREDWELL is found
5	improperly on Tribal lands at any time after the effective date of this resolution,
6	he shall be treated as a trespasser and appropriate legal action shall be taken
7	against him.
8	
9	BE IT FINALLY RESOLVED that all resolutions inconsistent with this resolution are rescinded,
10	and that this resolution shall become effective when ratified by the Principal
11	Chief.
