WHEREAS, the Tribal Realty Office has examined the records on file regarding the deceased's possessory holdings in Tribal trust land, and other documents, and has written this resolution to provide for the distribution of the deceased's possessory holding to his eligible heirs; and

WHEREAS, Tribal Council previously enacted Resolution No. 643 (2023) for the deceased's estate and the Tribal Realty Office is resubmitting this estate to correct a clerical error in the named heirs.

NOW, THEREFORE, BE IT RESOLVED by the Eastern Band of Cherokee Indians in Council Assembled, at which a quorum is present that the Tribal Council of the Eastern Band of Cherokee Indians does hereby recognize the heirs of Jefferson Toineeta: Albert David Toineeta Heirs: Deborah Jean Toineeta and the Estate of Sherry Marlene Toineeta; Robin Edward Toineeta Sr. Heirs: Robin Edward Toineeta Jr. and Veronica Lynn Toineeta; and the John Daniel Toineeta Heirs: Darrel Edward Toineeta, Estate of Joel Daniel Toineeta, Nehemiah Agina Toineeta, and Kerry Nathaniel Reed.

BE IT FURTHER RESOLVED that Wolftown Community Parcel No. 1296 (Remainder of Parcel No. 74), containing 0.329 acres, more or less, together with all improvements located thereon, be assigned to Albert David Toineeta Heirs: Deborah Jean Toineeta and the Estate of Sherry Marlene Toineeta; Robin Edward Toineeta Sr. Heirs: Robin Edward Toineeta Jr. and Veronica Lynn Toineeta; and the John Daniel Toineeta Heirs: Darrel Edward Toineeta, Estate of Joel Daniel Toineeta, Nehemiah Agina Toineeta, and Kerry Nathaniel Reed.

BE IT FURTHER RESOLVED that Resolution No. 643 (2023) is hereby rescinded.
