## 1 CHEROKEE COUNCIL HOUSE 2 CHEROKEE, NORTH CAROLINA 3 4 5 6 RESOLUTION NO. (2025) 7 8 A resolution to authorize the Tribe and Qualla Enterprises, LLC to amend the Promissory Note between them to provide for payments thereunder to be allocated to per capita and GenWell, as well as for other 9 purposes identified by the Tribe. 10 11 WHEREAS, taken together, Resolution No. 7 (2023) and Resolution No. 29 (2023) established that the 12 Tribe loaned \$50 million to Qualla Enterprises, LLC which was to be paid back 13 according to the terms of the Promissory Note entered by and between the LLC and the 14 15 Tribe; and 16 the Promissory Note was dated December 1, 2023, executed by both parties, an 17 WHEREAS, 18 amortization schedule supplied, and payment requirements imposed; and 19 the Promissory Note provided for interest to accrue in the first year, with no payments 20 WHEREAS, required, and payments to begin on January 1, 2025; and 21 22 23 in the interim between December 1, 2023 and January 1, 2025, Qualla Enterprises has WHEREAS, opened to the public and has begun to earn significant revenue which it must allocate to 24 several purposes, including payment of the Note, distributions for per capita, capital 25 26 improvements, and other needs and obligations; and 27 Qualla Enterprises cannot satisfy all of these needs and obligations at once; and 28 WHEREAS, 29 30 the Tribe established Qualla Enterprises to help diversify the Tribe's revenue sources and WHEREAS, to return money to Tribal members in the form of per capita or GenWell distributions; 31 32 and 33 the Tribe should authorize amendments to the Promissory Note and other necessary 34 WHEREAS. documents to allow Qualla Enterprises to make, and to allow the Tribe to accept, 35 payments to the Tribe which the Tribe may allocate and apply first to per capita and 36 GenWell distributions and, if the payments are large enough, to also pay down the debt 37 38 represented by the Promissory Note. 39 NOW THEREFORE BE IT RESOLVED, the Eastern Band of Cherokee Indians Tribal 40 Council, in Council assembled, at which a quorum is present, that the Tribe is hereby 41 42 authorized to amend the Promissory Note and other necessary documents, to allow Qualla Enterprises to make, and to allow the Tribe to accept, payments to the Tribe which 43 the Tribe may allocate and apply first to per capita and GenWell distributions and, if the 44 45 payments are large enough, to also pay down the debt represented by the Promissory 46 Note, and for other needs identified by the Tribe. 47 48 BE IT FINALLY RESOLVED that all resolutions that are inconsistent with this resolution are rescinded, and that this resolution shall become effective when ratified by the Principal 49 50 Chief. 51 52 53 Submitted by Michell Hicks, Principal Chief.
