RESOLUTION NO. _____ (2016)

WHEREAS, Joseph Arche Conseen (Deceased April 13, 2010), enrolled member of the Eastern Band of Cherokee Indians did not leave a Last Will and Testament; and

WHEREAS, Lorraine Conseen has qualified as the Administratrix of the estate of Joseph Arche Conseen and it is her desire that Joseph Arche Conseen's legal heirs be recognized as the successors in interest to his possessory holdings located in Cherokee Community.

NOW, THEREFORE, BE IT RESOLVED by the Eastern Band of Cherokee Indians in Council Assembled, at which a quorum is present that the Tribal Council of the Eastern Band of Cherokee Indians does hereby recognize the heir of Joseph Arche Conseen.

BE IT FURTHER RESOLVED that Debbie Lorraine Bradley Conseen (Surviving Spouse), Shauna Charmianne Jackson Teesatuskie, and Venyall La's James Edward Conseen, shall each receive a one third (1/3) Undivided Interest **Cherokee Village Community Parcel No. 75 (Part of Parcel No. 25)**, containing 0.993 acre, more or less, together with all improvements located thereon, Subject to Life Estate for Debbie Lorraine Bradley Conseen (Surviving Spouse), in accord with Cherokee Code §47-4(g)(1).

BE IT FURTHER RESOLVED that Debbie Lorraine Bradley Conseen (Surviving Spouse), Shauna Charmianne Jackson Teesatuskie, and Venyall La's James Edward Conseen, shall each receive a one third (1/3) Undivided Interest **Cherokee Village Community Parcel No. 101 (Part of Parcel No. 3)**, containing 0.23 acre, more or less, together with all improvements located thereon, Subject to Business Lease No. T-S52-1080-82.

BE IT FURTHER RESOLVED that Debbie Lorraine Bradley Conseen (Surviving Spouse), Shauna Charmianne Jackson Teesatuskie, and Venyall La's James Edward Conseen, shall each receive a one third (1/3) Undivided Interest in Jospoh Arche Conseen's (D) Undivided Interest in **Cherokee Village Community Parcel No. 6-B (Remainder of Parcel No. 6)**, containing 0.904 acres, more or less.

BE IT FURTHER RESOLVED that Debbie Lorraine Bradley Conseen (Surviving Spouse), Shauna Charmianne Jackson Teesatuskie, and Venyall La's James Edward Conseen, shall each receive a one third (1/3) Undivided Interest in Jospoh Arche Conseen's (D) Undivided Interest in **Cherokee Village Community Parcel No. 82 (Part of Parcel No. 3)**, containing 5.850 acres, more or less.

BE IT FINALLY RESOLVED that the Tribal Business Committee and the Bureau of Indian Affairs, Cherokee Agency, Division of Real Estate Services, are hereby authorized to carry out the intent of this resolution.
