10	A resolution to nominate three persons to the Governor of the State of North Carolina
11	so the Governor can appoint one of those persons to the Tribe's seat on the North Carolina
12	Boxing and Combat Sports Commission.

14	WHEREAS, the North Carolina Boxing and Combat Sports Commission is established in Sec. 143-650 through Sec. 143-659 of the North Carolina General Statutes; and

10 17	WHEREAS, the Commission is charged with regulating live boxing, kickboxing, and mixed
18	martial arts matches, whether professional, amateur, or sanctioned amateur, or
19	toughman events, in which admission is charged for viewing, or the contestants
20	compete for a purse or prize of value greater than twenty-five dollars (\$25.00) (GS
21	Sec. 143-652.1); and

23	WHEREAS, the Commission has six voting members, one of whom "shall be appointed by the
24	Governor for an initial term of three years, from nominations made by the Tribal
25 26	Council of the Eastern Band of the Cherokee, which shall nominate three individuals for the position" (GS Sec. 143-652.2(a)(6)); and
20 27	marviduals for the position (05 bee. 145-052.2(a)(0)), and
28	WHEREAS, persons who serve on the Commission are not paid by the State, but may have
29	certain expenses reimbursed; and

31	WHEREAS, the Tribe's voting seat on the Commission is vacant and the Tribe desires to
32	nominate three persons, for potential appointment by the Governor of one of
33	nominees, to the North Carolina Boxing and Combat Sports Commission.
34	NOW, THEREFORE BE IT RESOLVED by the Eastern Band of Cherokee Indians, in Annual
35 36	Council assembled, at which a quorum is present, that pursuant to GS Sec. 143-
37	652.2(a)(6), the Tribal Council hereby nominates the three persons named below for
38	appointment by the Governor of one of these person to the North Carolina Boxing
39	and Combat Sports Commission.
