17		tribe enjoying a government-to-government relationship with the United States;

21	WILKEAS,	to promote economic development, Tribal self-sufficiency and Tribal self- determination, the Tribal Council has previously authorized the establishment of	
22		two tribally-owned casinos offering Class III gaming activities as defined by the	
23		Indian Gaming Regulatory Act of 1988 ("IGRA"); and

25	WHEREAS,	the original casino gaming facility opened in November, 1997, is known as	
26		Harrah's Cherokee Casino Resort, and is located at 777 Casino Drive, Cherokee,	
27		North Carolina; the second facility opened in September, 2015, is known as	
28		Harrah's Cherokee Valley River Casino & Hotel, and is located at 777 Casino	
29 30		Parkway, Murphy, North Carolina; and	
31	WHEREAS,	the Tribe conducts its easing gaming activities at both locations with the 1-1-5	
32	WILKEAS,	the Tribe conducts its casino gaming activities at both locations with the help of Harrah's NC Casino Company, L.L.C. ("Harrah's"), a North Carolina limited	
33		liability company, which is an independent contractor to the Tribe and serves as	
34		manager of the Tribe's facilities; and

36	WHEREAS,	the contractual relationship between the Tribe and Harrah's is currently governed	
37		by, and both entities are parties to, the Second Amended and Restated Management	
38		Agreement which is referred to herein as the "Existing Management Agreement";

40	WILEDEAG	on January 0, 2025, proposed character the Friedland	
41 42	WHEREAS,	on January 9, 2025, proposed changes to the Existing Management Agreement were	
42 43		presented to Tribal Council in Resolution No. 375 (2025), which was deemed read and tabled for a work session and a substantive discussion at a later date; and
