RESOLUTION NO. 161 (2024)

WHEREAS, the Eastern Band of Cherokee (EBCI) Indians Natural Resources Program is responsible for protecting, preserving, and ensuring the wise utilization of the limited natural resources located on Tribal lands; and

WHEREAS, the Natural Resources Program has identified a funding opportunity from the North Carolina Department of Environmental Quality, Division of Water Resources to implement watershed restoration plans that will help restore waters impaired by non-point sources of pollution; and

WHEREAS, no personnel costs will be covered by this grant; and

WHEREAS, there is a grant match required in the estimated amount of \$160,000.

NOW THEREFORE BE IT RESOLVED by the Tribal Council of the Eastern Band of Cherokee Indians, in Council assembled and at which a quorum is present, that the EBCI Natural Resources Program is authorized to accept funds from the North Carolina Department of Environmental Quality Division of Water Resources in the estimated amount of \$240,000 for a total estimated project cost of \$400,000 for FY25-28.

BE IT FURTHER RESOLVED that the EBCI will contribute a grant match in the estimated amount of \$160,000 from the General Fund Grant Match line item.

BE IT FINALLY RESOLVED that the Principal Chief is authorized to carry out the intent of this resolution, which shall remain in effect until implemented or rescinded.
