A resolution for the Estate of Lucy Frances Bigmeat

WHEREAS, Lucy Francis Bigmeat (deceased June 20, 2025), enrolled member of the Eastern Band of Cherokee Indians did not leave a Last Will and Testament; and

WHEREAS, Louzett Standley and Rechanda Waldroup have qualified as Fiduciary Representatives of the estate of Lucy Francis Bigmeat in Cherokee Court Estate File No. 25-096; and

WHEREAS, The Tribal Realty Office has examined the records on file regarding the deceased's possessory holding in Tribal trust land, and other documents, and has written this resolution to provide for the distribution of the deceased's possessory holding to their eligible heirs.

NOW, THEREFORE, BE IT RESOLVED by the Eastern Band of Cherokee Indians in Council Assembled, at which a quorum is present that the Tribal Council of the Eastern Band of Cherokee Indians does hereby recognize the heirs of Lucy Francis Bigmeat: James Edward Bigmeat, (enrolled), Wesley Goines Bigmeat, (enrolled), Louzett Cecelia Standley, (enrolled), and Rechanda Waldroup, (enrolled).
