RESOLUTION NO. 443 (2022)

	WHEREAS,	the Eastern Band of Cherokee Indians owns fifty-percent of Balsam West FiberNet with partner Drake Enterprises; and			
	WHEREAS,	the enterprise value and revenue generating capacity of Balsam West FibertNet has grown significantly in the last twenty-four months representing a valuable asset to its owners; and			
	WHEREAS,	there has been a significant increase in competition throughout the region with a growing number of providers attempting to make entrance to the market; and			
	WHEREAS,	Balsam West FiberNet has built a superior product, customer service model, and business operation serving commercial and residential customers across Western North Carolina; and			
	WHEREAS,	the Tribal Council of the Eastern Band of Cherokee Indians approved Resolution No. 100 (2020) authorizing a loan to Balsam West FiberNet in an amount not to exceed \$4,000,000 for a term of ten years at a rate of 5% interest contingent on our equity partner providing the same with parity in terms; and			
	WHEREAS,	in response to increased competition in the market Balsam West FiberNet has launched various programs aimed at improving market share and requires additional flexibility in the strategic deployment of capital to grow and maintain current operations which will be potentially slowed by repayment; and			
	WHEREAS,	the EBCI's equity partner Drake Enterprises has agreed to convert the loan to an equity contribution to the company should the Eastern Band of Cherokee Indians choose to do the same.			
	NOW THEREFO	RE BE IT RESOLVED by the Tribal Council of the Eastern Band of Cherokee Indians in Council assembled, at which a quorum is present the loan not to exceed \$4,000,000 shall be converted and booked as an equity contribution to Balsam West FiberNet contingent on the EBCI's equity partner agreeing to the same with parity in terms.			
BE IT FURTHER RESOLVED this resolution shall serve to modify and cancel the original agreement under Section J. Modification of the Line of Credit Promissory Note between the Eastern Band of Cherokee Indians and Balsam West Fiber Not dated April 1, 2021					

BE IT FINALLY RESOLVED this resolution shall become effective upon ratification by the Principal Chief and shall remain
