- Linda Gail Parker Toineeta requests Tribal Council to recognize and confirm the WHEREAS. Last Will and Testament as to the distributions of Tribal Possessory holdings as provided in the will; and
- WHEREAS, Tribal Council passed Resolution No. 627 (2017) for the deceased on July 06. 2017 distributing Big Cover Community Parcel No. 364-B to Audrey Louise Walkingstick (enrolled); and
- Big Cove Community Parcel No. 313 and Big Cove Community Parcel No. 431, WHEREAS, was omitted from Resolution No. 627 (2017); and
  - the deceased's will states that all Tribal trust land to which the deceased WHEREAS, maintained a possessory interest in is to be distributed to Audrey Louise Walkingstick (enrolled).
  - NOW, THEREFORE, BE IT RESOLVED by the Eastern Band of Cherokee Indians in Council Assembled, at which a quorum is present that the Tribal Council of the Eastern Band of Cherokee Indians does hereby confirm the Last Will and Testament of Clyde Douglas Toineeta dated October 11, 2016.
  - BE IT FURTHER RESOLVED that a 1/3 Undivided Interest in Big Cove Community Parcel No. 313, containing 0.961 acres, more or less, together with all improvements located thereon, be assigned to Audrey Louise Walkingstick (enrolled).
  - BE IT FURTHER RESOLVED that a 1/3 Undivided Interest in Big Cove Community Parcel No. 431, containing 7.885 acres, more or less, together with all improvements located thereon, be assigned to Audrey Louise Walkingstick (enrolled).
  - BE IT FURTHER RESOLVED that the rest, remainder and residue of any possessory holdings in the estate shall be assigned to Audrey Louise Walkingstick (enrolled) as stated in the residuary clause of the will.
  - BE IT FINALLY RESOLVED that the Tribal Business Committee and the Tribal Realty Services, are hereby authorized to carry out the intent of this resolution.
