RESOLUTION NO. \_\_\_\_\_ (2018)

WHEREAS, Donald Edward Maney, (Deceased October 7, 2015), enrolled member of the Eastern Band of Cherokee Indians did not leave a Last Will and Testament; and

WHEREAS, Stephanie Dawn Maney has qualified as the Administratrix of the estate of Donald Edward Maney in Cherokee Court Estate File No. 15-062, and it is her desire that Donald Edward Maney's legal heirs be recognized as the successors in interest to his possessory holdings located in Painttown Community.

NOW, THEREFORE, BE IT RESOLVED by the Eastern Band of Cherokee Indians in Council Assembled, at which a quorum is present that the Tribal Council of the Eastern Band of Cherokee Indians does hereby recognize the heirs of Donald Edward Maney: Stephanie Dawn Maney (enrolled) and Donavon Alan Maney (enrolled).

BE IT FURTHER RESOLVED that **Painttown Community Parcel No. 309-K (Part of Parcel No. 309-H)**, containing 0.644 acres, more or less, be assigned to Stephanie Dawn Maney (enrolled) and Donavon Alan Maney (enrolled).

BE IT FURTHER RESOLVED that a 1/28<sup>th</sup> Undivided Interest in **Painttown Community Parcel No. 780 (Part of Parcels No. 70, 72, and all of Parcel No. 779)**, containing 1.036 acres, more or less, together with all improvements located thereon, be assigned to Stephanie Dawn Maney (enrolled) and Donavon Alan Maney (enrolled). **Subject to Lease No. T-S52-336-95.**

BE IT FURTHER RESOLVED that a 1/28<sup>th</sup> Undivided Interest in **Painttown Community Parcel No. 781 (Part of Parcel No. 72)**, containing 0.180 acres, more or less, together with all improvements located thereon, be assigned to Stephanie Dawn Maney (enrolled) and Donavon Alan Maney (enrolled).

BE IT FURTHER RESOLVED that a 1/28<sup>th</sup> Undivided Interest in **Painttown Community Parcel No. 70-E (Part of Parcel No. 70-A)**, containing 0.313 acres, more or less, together with all improvements located thereon, be assigned to Stephanie Dawn Maney (enrolled), and Donavon Alan Maney (enrolled).

BE IT FURTHER RESOLVED that a 1/28<sup>th</sup> Undivided Interest in **Painttown Community Parcel No. 70-G (Part of Parcel No. 70-F)**, containing 1.246 acres, more or less, be assigned to Stephanie Dawn Maney (enrolled) and Donavon Alan Maney (enrolled).

BE IT FURTHER RESOLVED that a 1/28<sup>th</sup> Undivided Interest in **Painttown Community Parcel No. 70-H (Remainder of Parcel No. 70-F)**, containing 0.073 acres, more or less, be assigned to Stephanie Dawn Maney (enrolled) and Donavon Alan Maney (enrolled).

BE IT FURTHER RESOLVED that a 1/28<sup>th</sup> Undivided Interest in **Painttown Community Parcel No. 70-I (Part of Parcel No. 70-D)**, containing 0.021 acres, more or less, be assigned to Stephanie Dawn Maney (enrolled) and Donavon Alan Maney (enrolled).

BE IT FURTHER RESOLVED that a 1/28<sup>th</sup> Undivided Interest in **Painttown Community Parcel No. 70-J (Remainder of Parcel No. 70-D)**, containing 0.678 acres, more or less, be assigned to Stephanie Dawn Maney (enrolled) and Donavon Alan Maney (enrolled).

BE IT FURTHER RESOLVED that a 1/28<sup>th</sup> Undivided Interest in **Painttown Community Parcel No. 73-A (Part of Parcel No. 73)**, containing 0.084 acres, more or less, together with all improvements located thereon, be assigned to Stephanie Dawn Maney (enrolled) and Donavon Alan Maney (enrolled).

BE IT FINALLY RESOLVED that the Tribal Business Committee and the Tribal Realty Services are hereby authorized to carry out the intent of this resolution.
