- the Tribal Realty Office has examined the records on file regarding the deceased's WHEREAS, possessory holdings in Tribal trust land, and other documents, and has written this resolution to provide for the distribution of the deceased's possessory holdings to his eligible heirs; and
- WHEREAS, the Administrator requests Tribal Council to recognize the deceased's eligible heirs under Tribal law, and to provide for the distribution of the deceased's possessory holdings to his eligible heirs.
- NOW, THEREFORE, BE IT RESOLVED by the Eastern Band of Cherokee Indians in Council Assembled, at which a quorum is present that the Tribal Council of the Eastern Band of Cherokee Indians does hereby recognize the heirs of Charles David Johnson: Dawn Renee Johnson (enrolled) and Anthony Dean Johnson (enrolled).
- BE IT FURTHER RESOLVED that a 1/6th Undivided Interest in Wolfetown Community Parcel No. 304, containing 13.79 acres, more or less, be assigned to Dawn Renee Johnson (enrolled), and Anthony Dean Johnson (enrolled).
- BE IT FURTHER RESOLVED that Wolfetown Community Parcel No. 489-B (Remainder of Parcel No. 489), containing 0.782 acres, more or less, together with all improvements located thereon, be assigned to Dawn Renee Johnson (enrolled), and Anthony Dean Johnson (enrolled).
