(2018)8 WHEREAS, Sections 143B-411.1 through 143B-411.4 of the North Carolina General Statutes 9 establish the "North Carolina Advisory Council on the Eastern Band of Cherokee 10 11 Indians"; and 12 the Advisory Council is within the North Carolina Department of Administration 13 WHEREAS and its purpose, expressed in N.C.G.S. Sec. 143B-411.2, is to "study on a 14 continuing basis the relationship between the Eastern Band of the Cherokee and 15 the State of North Carolina in order to resolve any matters of concern to the State 16 or the Tribe"; and 17 18 19 WHEREAS, the statutes creating the Advisory Council were first passed by the North Carolina General Assembly in 1984, but the Advisory Council has been dormant and 20 nobody has been appointed to it in many years; and 21 22 the Advisory Council provides a great opportunity to regularly share ideas and 23 WHEREAS, address issues of mutual concern with North Carolina officials; and 24 25 WHEREAS, N.C.G.S. Sec. 143B-411.1 states that the Advisory Council shall consist of 16 26 members, eight of whom shall be appointed by the Principal Chief of the Tribe 27 with the consent of the Tribal Council, and the other eight shall be designated or 28 29 appointed by the State; and 30 this resolution names the persons Principal Chief Sneed has identified for 31 WHEREAS, appointment to the Advisory Council, and he hereby requests Tribal Council's 32 33 consent for the appointments. 34 NOW, THEREFORE, BE IT RESOLVED by the Eastern Band of Cherokee Indians in Council 35 Assembled, at which a quorum is present, that the persons serving in the eight 36 positions identified below are hereby appointed to the North Carolina Advisory 37 Council on the Eastern Band of Cherokee Indians, with the consent of Tribal 38 Council: 39 40 41 (1) Tribal Council Chairman (2) One other Tribal Council representative chosen by Tribal Council 42 (3) Governmental Affairs Liaison (currently Dennis E. Taylor) 43 (4) Secretary of Commerce (currently Paula Wojotkowski) 44 45 (5) Attorney General (currently Michael W. McConnell) (6) Secretary of Treasury (currently Cory M. Blankenship) 46

5	BE IT FURTHER RESOLVED that the Tribe's appointments to the Advisory Council shall
6	serve thereon at the pleasure of the Principal Chief.

8	BE IT FINALLY RESOLVED that all resolutions that are inconsistent with this resolution are
9	rescinded, and that this resolution shall become effective when ratified by the
10	Principal Chief.
