24 25 WHEREAS, Estate Resolution No. 446 (1995) recognized the heirs of Levi Queen, including Thomas Queen among others, and distributed Wolfetown Community Parcel No. 748-F (Part of Parcel No. 748) and a 1/6th undivided interest in Wolfetown Community Parcel No. 748-G (Part of Parcel No. 748) to Reginald James Queen and Belinda Lee Queen as heirs of Thomas Queen, but no transfers were ever completed afterwards; and

Wolfetown Community Parcel No. 748-G (Part of Parcel No. 748) was the subject WHEREAS, of an Agreement to Division, dated October 22, 2003, to which the Thomas Queen heirs named as Reginald James Queen, Henry Allen Long, Jr., and Melvin Thomas Long, were to receive Wolfetown Community Parcel No. 748-R (Part of Parcel No. 748-G), and is therefore not a part of the deceased's estate; and
