RESOLUTION NO. _____ (2018)

WHEREAS, Eva Elizabeth Conseen Kalonaheskie, (Deceased March 18, 2013), enrolled member of the Eastern Band of Cherokee Indians left a Last Will and Testament, dated July 7, 2003, and

WHEREAS, Maurice Kalonaheskie has qualified as the Executor of the estate of Eva Elizabeth Conseen Kalonaheskie in Cherokee Court Estate File No. 13-042; and

WHEREAS, the Tribal Realty Office has examined the deceased's Will, the records on file regarding the deceased's possessory holdings in Tribal trust land, and other documents, and has written this resolution to provide for the distribution of the deceased's possessory holdings to her eligible heir; and

WHEREAS, the Executor requests Tribal Council to confirm the Last Will and Testament of Eva Elizabeth Conseen Kalonaheskie, to recognize her eligible heir under Tribal law, and to provide for the distribution of her possessory holdings to her eligible heir.

NOW, THEREFORE, BE IT RESOLVED by the Eastern Band of Cherokee Indians in Council Assembled, at which a quorum is present that the Tribal Council of the Eastern Band of Cherokee Indians does hereby confirm the Last Will and Testament of Eva Elizabeth Conseen Kalonaheskie dated July 7, 2003.

BE IT FURTHER RESOLVED that **Wolfetown Community Parcel No. 999 (Part of Parcel No. 847)**, containing 1.111 acres, more or less, together with all improvements located thereon, be assigned to Maurice Phillip Kalonaheskie (enrolled).

BE IT FURTHER RESOLVED that **Wolfetown Community Parcel No. 847 (Part of Parcel No. 734)**, containing 1.10 acres, more or less, be assigned to Maurice Phillip Kalonaheskie (enrolled).

BE IT FURTHER RESOLVED that **Wolfetown Community Parcel No. 1130 (Part of Parcel No. 120)**, containing 0.102 acres, more or less, be assigned to Maurice Phillip Kalonaheskie (enrolled).

BE IT FURTHER RESOLVED that **Wolfetown Community Parcel No. 748-V (Part of Parcel No. 748)**, containing 4.151 acres, more or less, be assigned to Maurice Phillip Kalonaheskie (enrolled).

BE IT FURTHER RESOLVED that the rest, remainder and residue of any possessory holdings in the estate shall be assigned to Maurice Phillip Kalonaheskie (enrolled) as stated in the residuary clause of the will.
