- WHEREAS, the Tribal Realty Office has examined the deceased's Will, the records on file regarding the deceased's possessory holdings in Tribal trust land, and other documents, and has written this resolution to provide for the distribution of the deceased's possessory holdings to her eligible heir; and
- WHEREAS, the Executor requests Tribal Council to confirm the Last Will and Testament of Eva Elizabeth Conseen Kalonaheskie, to recognize her eligible heir under Tribal law, and to provide for the distribution of her possessory holdings to her eligible heir.

- BE IT FURTHER RESOLVED that Wolfetown Community Parcel No. 847 (Part of Parcel No. 734), containing 1.10 acres, more or less, be assigned to Maurice Phillip Kalonaheskie (enrolled).
- BE IT FURTHER RESOLVED that Wolfetown Community Parcel No. 1130 (Part of Parcel No. 120), containing 0.102 acres, more or less, be assigned to Maurice Phillip Kalonaheskie (enrolled).
- BE IT FURTHER RESOLVED that Wolfetown Community Parcel No. 748-V (Part of Parcel No. 748), containing 4.151 acres, more or less, be assigned to Maurice Phillip Kalonaheskie (enrolled).
