RESOLUTION NO. \_\_\_\_\_ (2018)

WHEREAS, Emaline Bird Kalonaheskie, (deceased March 27, 2014), enrolled member of the Eastern Band of Cherokee Indians did not leave a Last Will and Testament; and

WHEREAS, Charles Kalonaheskie has qualified as the Administrator of the estate of Emaline Bird Kalonaheskie in Cherokee Court Estate File 14-037; and

WHEREAS, the Tribal Realty Office has examined the records on file regarding the deceased's possessory holdings in Tribal trust land, and other documents, and has written this resolution to provide for the distribution of the deceased's possessory holdings to her eligible heirs; and

WHEREAS, the Administrator requests Tribal Council recognize the deceased's eligible heirs under Tribal law, and to provide for the distribution of the deceased's possessory holdings to her eligible heirs.

NOW, THEREFORE, BE IT RESOLVED by the Eastern Band of Cherokee Indians in Council Assembled, at which a quorum is present that the Tribal Council of the Eastern Band of Cherokee Indians does hereby recognize the heirs of Emaline Bird Kalonaheskie: Charles Kalonaheskie (surviving enrolled spouse); Jesse Marurice Kalonaheskie (enrolled); Amy Darlene Kalonaheskie Postoak (enrolled); and the Jeremy Dean Kalonaheskie heirs: Jeremy Dean Kalonaheskie, Jr. (enrolled minor), Sherman Charles Kalonaheskie (enrolled minor), and Angelyn Faith Kalonaheskie (enrolled minor).

BE IT FURTHER RESOLVED that **Wolfetown Community Parcel No. 120-A (Part of Parcel No. 120)**, containing 1.009 acres, more or less, be assigned to Jesse Marurice Kalonaheskie (enrolled); Amy Darlene Kalonaheskie Postoak (enrolled); and the Jeremy Dean Kalonaheskie heirs: Jeremy Dean Kalonaheskie, Jr. (enrolled minor), Sherman Charles Kalonaheskie (enrolled minor), and Angelyn Faith Kalonaheskie (enrolled minor); subject to a life estate for the deceased's surviving enrolled spouse, Charles Kalonaheskie, pursuant to Cherokee Code Chapter 47-4(g)(1).

BE IT FURTHER RESOLVED that a 1/8<sup>th</sup> undivided interest in **Wolfetown Community Parcel No. 120-B (Remainder of Parcel No. 120)**, containing 61.578 acres, more or less, be assigned to Jesse Marurice Kalonaheskie (enrolled); Amy Darlene Kalonaheskie Postoak (enrolled); and the Jeremy Dean Kalonaheskie heirs: Jeremy Dean Kalonaheskie, Jr. (enrolled minor), Sherman Charles Kalonaheskie (enrolled minor), and Angelyn Faith Kalonaheskie (enrolled minor); subject to a life estate for the deceased's surviving enrolled spouse, Charles Kalonaheskie, pursuant to Cherokee Code Chapter 47-4(g)(1).

1 BE IT FURTHER RESOLVED that **Wolfetown Community Parcel No. 1424 (Part of Parcel**  
2 **No. 221)**, containing 1.1613 acres, more or less, be assigned to Jesse Marurice  
3 Kalonaheskie (enrolled); Amy Darlene Kalonaheskie Postoak (enrolled); and the  
4 Jeremy Dean Kalonaheskie heirs: Jeremy Dean Kalonaheskie, Jr. (enrolled minor),  
5 Sherman Charles Kalonaheskie (enrolled minor), and Angelyn Faith Kalonaheskie  
6 (enrolled minor); subject to a life estate for the deceased's surviving enrolled  
7 spouse, Charles Kalonaheskie, pursuant to Cherokee Code Chapter 47-4(g)(1).

9 BE IT FURTHER RESOLVED that a 1/8<sup>th</sup> undivided interest in **Wolfetown Community Parcel**  
10 **No. 1267-E (Part of Parcel No. 1267)**, containing 4.834 acres, more or less, be  
11 assigned to Jesse Marurice Kalonaheskie (enrolled); Amy Darlene Kalonaheskie  
12 Postoak (enrolled); and the Jeremy Dean Kalonaheskie heirs: Jeremy Dean  
13 Kalonaheskie, Jr. (enrolled minor), Sherman Charles Kalonaheskie (enrolled  
14 minor), and Angelyn Faith Kalonaheskie (enrolled minor); subject to a life estate  
15 for the deceased's surviving enrolled spouse, Charles Kalonaheskie, pursuant to  
16 Cherokee Code Chapter 47-4(g)(1).

18 BE IT FINALLY RESOLVED that the Tribal Business Committee and the Tribal Realty  
19 Services are hereby authorized to carry out the intent of this resolution.
