RESOLUTION NO. _____ (2019)

WHEREAS, Frances Darleen Cornwell Rogers, (deceased September 5, 2015), enrolled member of the Eastern Band of Cherokee Indians left a Last Will and Testament, dated November 12, 2014; and

WHEREAS, Barbara Sue Rogers Lovingood has qualified as the Executrix of the estate of Frances Darleen Cornwell Rogers in Cherokee Court Estate File No. 16-066; and

WHEREAS, the Tribal Realty Office has examined the deceased's Will, the records on file regarding the deceased's possessory holdings in Tribal trust land, and other documents, and has written this resolution to provide for the distribution of the deceased's possessory holding to her eligible heirs; and

WHEREAS, the Executrix requests Tribal Council to confirm the Last Will and Testament of Naomi Jane Queen, to recognize her eligible heir under Tribal law, and to provide for the distribution of her possessory holdings to her eligible heirs.

NOW, THEREFORE, BE IT RESOLVED by the Eastern Band of Cherokee Indians in Council Assembled, at which a quorum is present that the Tribal Council of the Eastern Band of Cherokee Indians does hereby confirm the Last Will and Testament of Frances Darleen Cornwell Rogers dated November 12, 2014, for the purpose of the distribution of the deceased's possessory holdings.

BE IT FURTHER RESOLVED that **Cherokee County Parcel No. 55 (Part of Parcel No. 12)**, containing 0.096 acres, more or less, together with all improvements located thereon, be assigned to Barbara Sue Rogers Lovingood (enrolled).

BE IT FURTHER RESOLVED that **Cherokee County Parcel No. 14 (Part of Parcel No. 57)**, containing 1.011 acres, more or less, together with all improvements located thereon, be assigned to Barbara Sue Rogers Lovingood (enrolled).

BE IT FURTHER RESOLVED that a ½ Undivided Interest in **Cherokee County Parcel No. 12-B (Part of Parcel No. 12)**, containing 105.890 acres, more or less, together with all improvements located thereon, be assigned to Barbara Sue Rogers Lovingood (enrolled) and Jimmy Ray Rogers (enrolled).

BE IT FURTHER RESOLVED that a ½ Undivided Interest in **Cherokee County Parcel No. 92 (Part of Parcel No. 12)**, containing 1.000 acre, more or less, together with all improvements located thereon, be assigned to Barbara Sue Rogers Lovingood (enrolled) and Jimmy Ray Rogers (enrolled).

BE IT FURTHER RESOLVED that the rest, remainder and residue of any possessory holdings in the estate shall be assigned to Barbara Sue Rogers Lovingood, Jimmy Ray Rogers,

1 and Terry Len Rogers (First Generation Heir) as stated in the residuary clause of
