## **RESOLUTION NO. 301 (2004)**

WHEREAS, the Snowbird Community youth facility has outgrown its current location; and

WHEREAS, in order to better serve the Snowbird youth, a new location is needed to allow for growth and expansion for after school and summer activities.

NOW, THEREFORE BE IT RESOLVED by the Eastern Band of Cherokee Indians in Council assembled, at which a quorum is present, the Tribal Council hereby authorizes the Principal Chief to use necessary program and staff to locate property which will accommodate the needs of the Snowbird Youth Center.

BE IT FURTHER RESOLVED a report shall be made to the Tribal Council during the

2004 Council session notifying Tribal Council of the location
options for the Snowbird Youth Center.

BE IT FINALLY RESOLVED this resolution shall become effective upon ratification by the Principal Chief.
