- WHEREAS, the Administratrix requests Tribal Council recognize the deceased's eligible heirs under Tribal law, and to provide for the distribution of the deceased's possessory holdings to her eligible heirs.
- NOW, THEREFORE, BE IT RESOLVED by the Eastern Band of Cherokee Indians in Council Assembled, at which a quorum is present that the Tribal Council of the Eastern Band of Cherokee Indians does hereby recognize the heirs of Lucetta Hill Ward: Consuela B.
