RESOLUTION NO. _____ (2019)

WHEREAS, Lucetta Hill Ward, (deceased November 12, 2017), enrolled member of the Eastern Band of Cherokee Indians did not leave a Last Will and Testament; and

WHEREAS, Consuela B. Girty has qualified as the Administratrix of the estate of Lucetta Hill Ward in Cherokee Court Estate File No. 17-072; and

WHEREAS, the Tribal Realty Office has examined the records on file regarding the deceased's possessory holding in Tribal trust land, and other documents, and has written this resolution to provide for the distribution of the deceased's possessory holdings to her eligible heirs; and

WHEREAS, the Administratrix requests Tribal Council recognize the deceased's eligible heirs under Tribal law, and to provide for the distribution of the deceased's possessory holdings to her eligible heirs.

NOW, THEREFORE, BE IT RESOLVED by the Eastern Band of Cherokee Indians in Council Assembled, at which a quorum is present that the Tribal Council of the Eastern Band of Cherokee Indians does hereby recognize the heirs of Lucetta Hill Ward: Consuela B. Girty (enrolled) and Joseph Calvin Ward (enrolled).

BE IT FURTHER RESOLVED that a 1/7th undivided interest in **Big Cove Community Parcel No. 44** containing 0.7 acres, more or less, together with all improvements located thereon, be assigned to Consuela B. Girty (enrolled) and Joseph Calvin Ward (enrolled).

BE IT FURTHER RESOLVED that a 1/7th undivided interest in **Big Cove Community Parcel No. 662-V (Part of Parcel No. 662-B)** containing 10.808 acres, more or less, be assigned to Consuela B. Girty (enrolled) and Joseph Calvin Ward (enrolled).

BE IT FURTHER RESOLVED that a 1/168th undivided interest in **Big Cove Community Parcel No. 701-E (Part of Parcel No. 701)** containing 24.982 acres, more or less, be assigned to Consuela B. Girty (enrolled) and Joseph Calvin Ward (enrolled).

BE IT FURTHER RESOLVED that a 1/56th undivided interest in **Big Cove Community Parcel No. 701-J (Remainder of Parcel No. 701-E)** containing 23.759 acres, be assigned to Consuela B. Girty (enrolled) and Joseph Calvin Ward (enrolled).

BE IT FURTHER RESOLVED that a 1/7th undivided interest **Big Cove Community Parcel No. 701-I (Part of Parcel No. 701-H)** containing 0.279 acres, more or less, be assigned to Consuela B. Girty (enrolled) and Joseph Calvin Ward (enrolled).
