ordinance no. <u>332</u>(2018)

- WHEREAS, The Charter and Governing Document authorizes and empowers the Eastern Band of Cherokee Indians to adopt laws for the government of the Tribe; and
- WHEREAS, Tribal Council members have been approving contracts pursuant to Cherokee Code Sections 117-19 and 117-33 in the amounts of \$50,000 or more thru their role on Business Committee; and
- WHEREAS, To be more effective in the legislative and budget process, Tribal Council would now like contracts approved by Business Committee which are \$10,000.00 or more.
- NOW THEREFORE BE IT ORDAINED by the Tribal Council of the Eastern Band of Cherokee Indians assembled, at which a quorum is present, that Cherokee Code Section 117-19(a) is amended to read as follows:

"Sec. 117-19. - Contracts with Tribe.

- (a) Before a Contract with the Eastern Band of Cherokee Indians shall be valid and binding the following shall occur:
- (1) A Contract in an amount less than \$50,000.00 \$10,000.00 which complies with all budget, financial, and legal requirements for that program and the Tribe, and is within the fiscal parameters of the Annual Budget approved by Tribal Council, may be executed by the Principal Chief.
- (2) A Contract in an amount of \$50,000.00 \$10,000.00 or more which complies with all budget, financial, and legal requirements for that program and the Tribe, and is within the fiscal parameters of the Annual Budget approved by the Tribal Council, shall have the approval of the Business Committee before being executed by the Principal Chief except that no contract over \$50,000.00 \$10,000.00 from the Tribal Operations Program shall require Business Committee approval.
- (b) All Contracts shall bear the signature of the Principal Chief before they are valid and binding on the Eastern Band of Cherokee Indians."
- BE IT FURTHER ORDAINED that this amendment shall be effective upon ratification by the Principal Chief, and all prior ordinances and resolutions that are inconsistent with this ordinance are rescinded.
