- WHEREAS, the CTAS provides a single application and coordinated approach in Fiscal Year 2019 competitive grant announcement grant funding, specifically for federally-recognized Tribes; and
- **WHEREAS**, the CTAS provides grant resources through DOJ components in an effort to best addresses tribes' concerns related to public safety, criminal and juvenile justice, and the needs of victims or survivors of domestic violence, child abuse, sexual assault, and other crimes.; and
- **WHEREAS**, no match requirement is necessary for the Program categories of interest to the EBCI.
- **WHEREAS**, the grant budget allows for \$573,040 in salaries.

NOW, THEREFORE BE IT RESOLVED by the Tribal Council of the Eastern Band of Cherokee Indians in Council assembled where a quorum is present that the Grant Compliance Office is authorized to coordinate and submit an application to DOJ for CTAS for FY20 - FY22.

BE IT FINALLY RESOLVED that the Principal Chief of the Eastern Band of Cherokee Indians is authorized to carry out the intent of this resolution, which shall remain in effect until implemented or rescinded.
