45 46 47 RESOLUTION NO. (2019)

- WHEREAS, Darrell Dwight Ross, (deceased May 12, 2016), enrolled member of the Eastern Band of Cherokee Indians left a Last Will and Testament, dated March 1, 2016, and
- WHEREAS, Delbert Dwight Ross qualified as the Executor of the estate of Darrell Dwight Ross in Cherokee Court Estate File No. 16-037; and
- WHEREAS, the Tribal Realty Office has examined the deceased's Will, the records on file regarding the deceased's possessory holdings in Tribal trust land, and other documents, and has written this resolution to provide for the distribution of the deceased's possessory holdings to his eligible heir; and
- WHEREAS, the Executrix requests Tribal Council to confirm the Last Will and Testament of Darrell Dwight Ross, to recognize his eligible heir under Tribal law, and to provide for the distribution of his possessory holdings to his eligible heir.
- NOW, THEREFORE, BE IT RESOLVED by the Eastern Band of Cherokee Indians in Council Assembled, at which a quorum is present that the Tribal Council of the Eastern Band of Cherokee Indians does hereby confirm the Last Will and Testament of Darrell Dwight Ross dated March 1, 2016, for the purpose of distribution of the deceased's possessory holdings.
- BE IT FURTHER RESOLVED that a 1/4th Undivided Interest in Big Cove Community Parcel No. 123, containing 0.93 acres, more or less, together with all improvements located thereon, be assigned to Delbert Dwight Ross (enrolled).
- BE IT FURTHER RESOLVED that a 1/4th Undivided Interest in Big Cove Community Parcel No. 17-A (Part of Parcel No. 117), containing 11.810 acres, more or less, be assigned to Delbert Dwight Ross (enrolled).
- BE IT FURTHER RESOLVED that a 1/4th Undivided Interest in Big Cove Community Parcel No. 131 (Part of Parcel No. 32), containing 0.72 acres, more or less, be assigned to Delbert Dwight Ross (enrolled).
- BE IT FURTHER RESOLVED that a 1/16th Undivided Interest in Big Cove Community Parcel No. 32-B (Part of Parcel No. 32), containing 0.522 acres, more or less, be assigned to Delbert Dwight Ross (enrolled).

1	BE IT FURTHER RESOLVED that a 1/16th Undivided Interest in Big Cove Community Parcel
2	No. 32-C (Remainder of Parcel No. 32), containing 8.416 acres, more or less, be
3	assigned to Delbert Dwight Ross.

5	BE IT FURTHER RESOLVED that the rest, remainder and residue of any possessory holdings in
6	the estate shall be assigned to Delbert Dwight Ross (enrolled) as stated in the
7	residuary clause of the will.

9	BE IT FINALLY RESOLVED that the Tribal Business Committee and the Tribal Realty
10	Services are hereby authorized to carry out the intent of this resolution.
