	RESOLUTION NO. (2020)
WHEREAS,	the Qualla Education Collaborative (QEC) has established a sub-committee to identify the service and program gaps for the Eastern Band of Cherokee Indians (EBCI) peoples with developmental and intellectual disabilities, and;
WHEREAS,	the QEC sub-committee has determined that a needs assessment and service evaluation are needed to identify EBCI workforce, training, housing and caretaker opportunities for health equity for the EBCI peoples with developmental and intellectual disabilities, and;
WHEREAS,	the individuals with developmental and intellectual disabilities have individualized Education Program (IEP) Plans throughout grade school and college to accommodate their educational and developmental needs and there is a need to have accommodations in place to assist these individuals as they make the transition into adulthood to ensure of their wellbeing personally and professionally, and;
WHEREAS	IEP data from Cherokee Central Schools alone indicates that 21% of the student body will be in need of assistance after grade school or college. IEP categories are of the following but not limited to: • Autism Spectrum Disorder • Deaf-blindness • Deafness • Developmental Delay (ages 3-7, must be changed by age 8) • Emotional Disability • Hearing Impairment (Hard of Hearing) • Intellectual Disabilities • Orthopedic Impairment • Other Health Impairment • Specific Learning Disability • Speech or Language Impairment • Visual Impairment, including blindness
NOW THERE	FORE BE IT RESOLVED by the Eastern Band of Cherokee Indians in Council assembled, at which a quorum is present, the Tribal Council instructs the to submit advertisements for Request for Proposal (RFP) for a consultant company to perform a needs assessment and service evaluation to identify opportunities for improvement and development of current services not to exceed \$75,000 to be funded from The timeline for a needs assessment and service evaluation should conclude within a six month period with action steps ready to implement amongst the EBCI.
