WHEREAS, Pursuant the Development and Construction Agreement between the Eastern Band of Cherokee Indians and Harrah's NC Casino Company, L.L.C, the Developer agrees to fund, during the term of the Management Agreement, an educational fund jointly directed by the EBCI and Harrah's; and

WHEREAS, Resolution 676 (1997) established the Harrah's Scholarship Fund to fulfill this agreement to further the educational opportunities available to EBCI tribal citizens; and

WHEREAS, Resolution 676 (1997) appointed two individuals to represent the EBCI on this Scholarship Fund with the third position being appointed by Harrah's Cherokee Casino Resort to develop policies and thereafter administer the Fund; and

WHEREAS, Additional representation from both entities is needed to ensure a more equitable distribution of duties and to better carry out said policies; and

WHEREAS, Harrah's Cherokee Casino Resort and Principal Chief Richard Sneed desire to appoint two additional representatives to the Harrah's Scholarship Fund with one being appointed by Harrah's Cherokee Casino Resort and the other being nominated by Principal Chief Richard Sneed pending approval of Tribal Council; and

WHEREAS, Both entities desire to create term limits for the EBCI and Harrah's appointees with the exception of the position on the Fund assumed by Harrah's Cherokee Casino Resort's General Manager.
