25	WHEREAS,	in pursuit of this development project and as contemplated by the parties, Experientia has entered a pre-development agreement with the TCGE,

31	WHEREAS,	the pre-development agreement expires on January 31, 2020, and due to

38	WHEREAS,	to bridge that gap and to keep the project on-track, Experientia is
39		requesting \$2 million in supplementary funding from the Tribe; and
40		, this additional funding will ultimately be returned by Experientia to the
41	WHEREAS,	Tribe by making the Tribe an equity partner in the development, or by
42 42		repayment from commercial loans Experientia will obtain to fund full
43 44		development of the project, or by some other mechanism to be negotiated

1 2	WHEREAS,	the TCGE and the Tribe have invested millions of dollars and almost two years of work with Experientia to move the project forward; and

4	WHEREAS,	this project is a critical part of the Tribe's effort to bring new business to
5		Cherokee and to diversify and expand the Tribe's economy; and

7	WHEREAS,	the TCGE and the Tribe should continue to move forward with
8		Experientia on the project and should provide the supplementary funding
9		requested.

11	NOW THER	EFORE BE IT RESOLVED by the Tribal Council of the Eastern Band of
12		Cherokee Indians assembled, at which a quorum is present, that in
13		addition to the project funding contributed by the Tribe under Resolution
14		No. 192 (2018), the Tribe shall contribute an additional \$2 million dollars
15		to the TCGE to be earmarked to pay Experientia's pre-development
16		expenses consistent with Resolution No. 192 (2018).

18	BE IT FURT	HER RESOLVED that this resolution shall be effective upon ratification by
19		the Principal Chief, and all prior resolutions that are inconsistent with this
20		resolution are rescinded, except for budget resolutions approved as part o
21		Tribal Council's annual budgeting process.
