Resolution No. 06 (2020)

WHEREAS Cherokee Code Chapter 117-50 Section A require the approval of Tribal

Council to engage with lobbyists on the state and federal levels, and;

WHEREAS the Office of the Principal Chief desires to engage with a lobbyist in the state

of Virginia, and;

WHEREAS Cherokee Code Chapter 117-50 Section B requires the approval of Tribal

Council to present legislation on the state or federal level, and;

WHEREAS the Office of the Principal Chief desires to work with a Virginia-based

lobbyist to promote the best interests of the EBCI in the Virginia commercial

gaming legislation.

NOW THEREFORE BE IT RESOLVED by the Tribal Council of the Eastern Band of Cherokee Indians in Council assembled at which a quorum is present that the EBCI Tribal Council hereby approves the Office of the Principal Chief to contract with a lobbying firm in the state of Virginia.

BE IT FURTHER RESOLVED that the Virginia-based lobbyist may work on behalf the EBCI to amend Virginia's commercial gaming legislation to pursue commercial gaming opportunities for the EBCI.

BE IT FINALLY RESOLVED that all resolutions that are inconsistent with this resolution are rescinded and that this resolution shall become effective upon ratification by the Principal Chief.
