WHEREAS, the Executive Committee has reviewed and approved plans and position descriptions to make needed changes and updates to program actions, and

WHEREAS, the current Tribal Realty Clerk (Position #972242009), Land Transfer Clerk (Position 3906542007), Land Committee Administrative Clerk (Position #906542006), and Business Committee Administrative Clerk (Position #906242003) position descriptions were written to become Land Record Specialists that report to the Realty Land Records Manager, and

WHEREAS, the current Survey Technician (Position #907037003) has been written to become Survey CAD Specialist (Position #907037501) that reports to the Tribal Survey Manager, and

WHEREAS, the attached organizational charts illustrate the existing and new chain of managements for Surveying and Realty Services.

NOW THEREFORE BE IT RESOLVED by the Eastern Band of Cherokee Indians, at which a quorum is present that the positions Tribal Realty Clerk, Land Transfer Clerk, Land Committee Administrative Clerk, and Business Committee Administrative Clerk are approved to become Land Record Specialists (Position #906237501, #906237502, #906237503, and #906237504) and shall report to the Realty Land Records Manager as detailed in the position description approved by Executive Committee and Certified by Human Resources.

BE IT FURTHER RESOLVED that the Survey Technician (Position #907037003) is approved to become Survey CAD Specialist (Position #907037501) and shall report to the Tribal Survey Manager, which shall be noted in the appropriate Job Description.

BE IT FURTHER RESOLVED that the attached organizational charts are approved to illustrate the changes to Tribal Realty's organizational structure.

BE IT FINALLY RESOLVED that all other resolutions in conflict are now rescinded and the Principal Chief, Attorney General's Office, and Tribal Realty Services are authorized to carryout out the intent of this resolution, which shall remain in effect until implemented or rescinded.
