WHEREAS, the Administratrix requests Tribal Council recognize the deceased's eligible heirs under Tribal law, and to provide for the distribution of the deceased's possessory holdings to his eligible heirs.

NOW, THEREFORE, BE IT RESOLVED by the Eastern Band of Cherokee Indians in Council Assembled, at which a quorum is present that the Tribal Council of the Eastern Band of Cherokee Indians does hereby recognize the heir of Xavier Ryan French to be Monika Mariya Toineeta (enrolled).

BE IT FURTHER RESOLVED that Xavier Ryan French's Undivided Interest in Big Cove Community Parcel No. 715-A (Part of Parcel No. 715), containing 0.116 acres, more or less, be assigned to Monika Mariya French Toineeta (enrolled).

BE IT FURTHER RESOLVED that Xavier Ryan French's Undivided Interest in Big Cove Community Parcel No. 715-B (Part of Parcel No. 715), containing 0.095 acres, more or less, be assigned to Monika Mariya French Toineeta (enrolled).

BE IT FURTHER RESOLVED that a Xavier Ryan French's Undivided Interest in **Big Cove Community Parcel No. 715-C (Part of Parcel No. 715),** containing 2.923 acres, more or less, be assigned to Monika Mariya Toineeta (enrolled).

BE IT FINALLY RESOLVED that the Tribal Business Committee and the Tribal Realty Services are hereby authorized to carry out the intent of this resolution.
