10 WHEREAS, Xavier Ryan French (deceased February 2, 2019), enrolled member of the Eastern
11 Band of Cherokee Indians did not leave a Last Will and Testament; and
12

13 WHEREAS, Monika Mariya French Toineeta has qualified as the Administratrix of the estate
14 of Michael Ray French in Cherokee Court Estate File 19-046; and
15

16 WHEREAS, the Tribal Realty Office has examined the records on file regarding the deceased's
17 possessory holdings in Tribal trust land, and other documents, and has written this
18 resolution to provide for the distribution of the deceased's possessory holdings to
19 his eligible heirs; and
20

21 WHEREAS, the Administratrix requests Tribal Council recognize the deceased's eligible heirs
22 under Tribal law, and to provide for the distribution of the deceased's possessory
23 holdings to his eligible heirs.

25 NOW, THEREFORE, BE IT RESOLVED by the Eastern Band of Cherokee Indians in Council
26 Assembled, at which a quorum is present that the Tribal Council of the Eastern
27 Band of Cherokee Indians does hereby recognize the heir of Xavier Ryan French
28 to be Monika Mariya Toineeta (enrolled).

30 BE IT FURTHER RESOLVED that Xavier Ryan French's Undivided Interest in **Big Cove**
31 **Community Parcel No. 715-A (Part of Parcel No. 715)**, containing 0.116 acres,
32 more or less, be assigned to Monika Mariya French Toineeta (enrolled).
33

34 BE IT FURTHER RESOLVED that Xavier Ryan French's Undivided Interest in **Big Cove**
35 **Community Parcel No. 715-B (Part of Parcel No. 715)**, containing 0.095 acres,
36 more or less, be assigned to Monika Mariya French Toineeta (enrolled).
37

38 BE IT FURTHER RESOLVED that a Xavier Ryan French's Undivided Interest in **Big Cove**
39 **Community Parcel No. 715-C (Part of Parcel No. 715)**, containing 2.923 acres,
40 more or less, be assigned to Monika Mariya Toineeta (enrolled).
41

42 BE IT FINALLY RESOLVED that the Tribal Business Committee and the Tribal Realty
43 Services are hereby authorized to carry out the intent of this resolution.


