NOW, THEREFORE, BE IT RESOLVED by the Eastern Band of Cherokee Indians in Council Assembled, at which a quorum is present that the Tribal Council of the Eastern Band of Cherokee Indians does hereby recognize the heirs of Juanita Reloris Walkingstick Hornbuckle: Kurt Marcus Stewart, Jr. (enrolled) and Laura Danielle Hornbuckle (enrolled).

BE IT FURTHER RESOLVED that Birdtown Community Parcel No. 543 (Part of Parcel No. 377), containing 0.966 acres, more or less, together with all improvements located thereon, be assigned to Kurt Marcus Stewart, Jr. (enrolled) and Laura Danielle Hornbuckle (enrolled).

BE IT FURTHER RESOLVED that a ½ undivided interest in Wolfetown Community Parcel No. 639-E (Part of Parcel No. 639-A), containing 2.696 acres, more or less, be assigned to Kurt Marcus Stewart, Jr. (enrolled) and Laura Danielle Hornbuckle (enrolled).

BE IT FINALLY RESOLVED that the Tribal Business Committee and Tribal Realty Services are hereby authorized to carry out the intent of this resolution.
