10 WHEREAS, Juanita Reloris Walkingstick Hornbuckle (deceased December 10, 2014), enrolled
11 member of the Eastern Band of Cherokee Indians did not leave a Last Will and
12 Testament; and

14 WHEREAS, an estate for the deceased had been opened in Cherokee Court Estate File 16-050
15 and the only assets in the estate left to be distributed are his possessory holdings;
16 and

18 WHEREAS, the Tribal Realty Office has examined the records on file regarding the deceased's
19 possessory holdings in Tribal trust land, and other documents, and has written this
20 resolution to provide for the distribution of the deceased's possessory holdings to
21 his eligible heirs.

23 NOW, THEREFORE, BE IT RESOLVED by the Eastern Band of Cherokee Indians in Council
24 Assembled, at which a quorum is present that the Tribal Council of the Eastern
25 Band of Cherokee Indians does hereby recognize the heirs of Juanita Reloris
26 Walkingstick Hornbuckle: Kurt Marcus Stewart, Jr. (enrolled) and Laura Danielle
27 Hornbuckle (enrolled).

29 BE IT FURTHER RESOLVED that **Birdtown Community Parcel No. 543 (Part of Parcel No.**
30 **377)**, containing 0.966 acres, more or less, together with all improvements located
31 thereon, be assigned to Kurt Marcus Stewart, Jr. (enrolled) and Laura Danielle
32 Hornbuckle (enrolled).

34 BE IT FURTHER RESOLVED that a ½ undivided interest in **Wolfetown Community Parcel**
35 **No. 639-E (Part of Parcel No. 639-A)**, containing 2.696 acres, more or less, be
36 assigned to Kurt Marcus Stewart, Jr. (enrolled) and Laura Danielle Hornbuckle
37 (enrolled).

39 BE IT FINALLY RESOLVED that the Tribal Business Committee and Tribal Realty Services
40 are hereby authorized to carry out the intent of this resolution.
