11 Eastern Band of Cherokee Indians did not leave a Last Will and Testament; and

13 WHEREAS, an estate has been opened in Cherokee Court Estate File No. 18-058, and the only
14 asset remaining in the estate is a single possessory holding in Tribal Trust Land;

17 WHEREAS, the Tribal Realty Office has examined the records on file regarding the deceased's
18 possessory holding in Tribal trust land, and other documents, and has written this
19 resolution to provide for the distribution of the deceased's possessory holding to
20 her eligible heir.

22 NOW, THEREFORE, BE IT RESOLVED by the Eastern Band of Cherokee Indians in Council
23 Assembled, at which a quorum is present that the Tribal Council of the Eastern
24 Band of Cherokee Indians does hereby recognize the heir of Geraldine Palmer
25 Robertson: Janie Marie Hughes (enrolled).

27 BE IT FURTHER RESOLVED that **Cherokee County Parcel No. 196-Q (Part of Parcel No.**
28 **196-A)**, containing 1.00 acre, more or less, together with all improvements
29 located thereon, be assigned to Janie Marie Hughes (enrolled).

31 BE IT FINALLY RESOLVED that the Tribal Business Committee and the Tribal Realty
32 Services are hereby authorized to carry out the intent of this resolution.
