RESOLUTION NO. 59 (2019)

WHEREAS, Barbara Jeanette Cooper Strickland (deceased December 26, 2013), enrolled member of the Eastern Band of Cherokee Indians left a Last Will and Testament, dated October 23, 1998, and

WHEREAS, Casey Cooper qualified as the Executor of the estate of Barbara Jeanette Cooper Strickland in Cherokee Court Estate File No. 15-033; and

WHEREAS, the Tribal Realty Office has examined the deceased's Will, the records on file regarding the deceased's possessory holdings in Tribal trust land, and other documents, and has written this resolution to provide for the distribution of the deceased's possessory holdings to her eligible heirs; and

WHEREAS, the Executor requests Tribal Council to confirm the Last Will and Testament of Barbara Jeanette Cooper Strickland, to recognize her eligible heirs under Tribal law, and to provide for the distribution of the possessory holdings named in the deceased's Last Will and Testament to her eligible heirs.

NOW, THEREFORE, BE IT RESOLVED by the Eastern Band of Cherokee Indians in Council Assembled, at which a quorum is present that the Tribal Council of the Eastern Band of Cherokee Indians does hereby confirm the Last Will and Testament of Barbara Jeanette Cooper Strickland dated October 23, 1998.

BE IT FURTHER RESOLVED that Lower Cherokee Community Parcel No. 123, containing 0.599 acres, more or less, together with all improvements located thereon, be assigned to Katherine Amelia Cooper (enrolled), subject to Life Estate for Robert Arnold Cooper (enrolled).

BE IT FURTHER RESOLVED that a 1/8th undivided interest in Lower Cherokee Community Parcel No. 127-F, containing 9.918 acres, more or less, together with all improvements located thereon, be assigned to Kenneth Ray Cline (First Generation Descendant).

BE IT FURTHER RESOLVED that the rest, remainder and residue of any possessory holdings in the estate shall be assigned to Kenneth Ray Cline (First Generation Descendant) as stated in the residuary clause of the will.

BE IT FINALLY RESOLVED that the Tribal Business Committee and the Tribal Realty Services are hereby authorized to carry out the intent of this resolution.
