RESOLUTION NO. 60 (2019)

WHEREAS, Mike Leroy Thompson, (Deceased December 11, 2016), enrolled member of the Eastern Band of Cherokee Indians left a Last Will and Testament, dated March 26, 2002, and

WHEREAS, Sarah Thompson Toineeta has qualified as the Executrix of the estate of Mike Leroy Thompson and it is her desire that the Last Will and Testament of Mike Leroy Thompson be recognized and confirmed by the Eastern Band of Cherokee Indians.

NOW, THEREFORE, BE IT RESOLVED by the Eastern Band of Cherokee Indians in Council Assembled, at which a quorum is present that the Tribal Council of the Eastern Band of Cherokee Indians does hereby confirm the Last Will and Testament of Mike Leroy Thompson dated March 26, 2002.

BE IT FURTHER RESOLVED that **Wolfetown Community Parcel No. 515-D (Part of the Alice & Jackson Thompson Estate)**, containing 0.693 acres, more or less, be assigned to Sarah Nicole Thompson Toineeta (enrolled).

BE IT FURTHER RESOLVED that **Wolfetown Community Parcel No. 515-F (Remainder of Parcel No. 515-A)**, containing 0.256 acres, more or less, together with all improvements located thereon, be assigned to Sarah Nicole Thompson Toineeta (enrolled).

BE IT FURTHER RESOLVED that **Wolfetown Community Parcel No. 515-G (Part of Parcel No. 515-A)**, containing 1.000 acres, more or less, be assigned to Sarah Nicole Thompson Toineeta (enrolled).

BE IT FURTHER RESOLVED that **Wolfetown Community Parcel No. 515-H (Remainder of Parcel No. 515-A)**, containing 3.745 acres, more or less, be assigned to Sarah Nicole Thompson Toineeta (enrolled).

BE IT FURTHER RESOLVED that **Wolfetown Community Parcel No. 515-L (Remainder of Parcel No. 515-E)**, containing 48.463 acres, more or less, be assigned to Sarah Nicole Thompson Toineeta (enrolled).

BE IT FURTHER RESOLVED that **Wolfetown Community Parcel No. 515-M (Remainder of Parcel No. 515-E)**, containing 7.443 acres, more or less, be assigned to Sarah Nicole Thompson Toineeta (enrolled).

BE IT FURTHER RESOLVED that the rest, remainder and residue of any possessory holdings in the estate shall be assigned to Sarah Nicole Thompson Toineeta as stated in the residuary clause of the will.
