10 WHEREAS, Sherry Lynn Owle Mejia (deceased September 27, 2015), enrolled member of the  
11 Eastern Band of Cherokee Indians did not leave a Last Will and Testament; and  
12

13 WHEREAS, Phillip Joseph Owle qualified as the Administrator of the estate of Sherry Lynn  
14 Owle Mejia in Cherokee Court Estate File No. 16-001; and  
15

16 WHEREAS, the Tribal Realty Office has examined the records on file regarding the deceased's  
17 possessory holdings in Tribal trust land, and other documents, and has written this  
18 resolution to provide for the distribution of the deceased's possessory holdings to  
19 her eligible heirs; and  
20

21 WHEREAS, the Administrator requests Tribal Council recognize the deceased's eligible heirs  
22 under Tribal law, and to provide for the distribution of the deceased's possessory  
23 holdings to her eligible heirs.

25 NOW, THEREFORE, BE IT RESOLVED by the Eastern Band of Cherokee Indians in Council  
26 Assembled, at which a quorum is present that the Tribal Council of the Eastern  
27 Band of Cherokee Indians does hereby recognize the heirs of Sherry Lynn Owle  
28 Mejia: Phillip Joseph Owle (enrolled), Reyna Mae Owle Perez (enrolled), and  
29 Korrina Lynn Owle Perez (enrolled).  
30

31 BE IT FURTHER RESOLVED that ½ Undivided Interest in **Painttown Community Parcel No.**  
32 **617 (Part of Parcel No. 301)**, containing 1.010 acres, more or less, be assigned to  
33 Phillip Joseph Owle (enrolled), Reyna Mae Owle Perez (enrolled), and Korrina  
34 Lynn Owle Perez (enrolled).  
35

36 BE IT FURTHER RESOLVED that **Painttown Community Parcel No. 563 (Part of Parcel**  
37 **No. 301)**, containing 0.929 acre, more or less, together with all improvements  
38 located thereon, be assigned to Phillip Joseph Owle (enrolled), Reyna Mae Owle  
39 Perez (enrolled), and Korrina Lynn Owle Perez (enrolled), subject to the current  
40 HIP assignment and existing Grant Agreement.

42 BE IT FINALLY RESOLVED that the Tribal Business Committee and the Tribal Realty  
43 Services are hereby authorized to carry out the intent of this resolution.
